Thank you for writing to the County of Rock Island with your request for information pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq.

On August 4, 2017, you requested the following documents:

*August 1, 2013 through July 31, 2017 any and all information written; documented meeting notes; email correspondence; text correspondence / conversation; mail correspondence of the following:*

*Any and all documents, emails, reports, memos, letter submissions, correspondence, meeting notes on Rock Island County policies, amendments to policies, newly established policies, Rock Island County Board resolutions introduced, Rock Island County Board resolutions passed, Rock Island County Board resolutions amended as these items relate to GENERAL POLICY REGARDING PENSION PLANS, MANDATORY PARTICIPATION IN THE IMRF PENSION PLAN, and INDIVIDUAL OPT OUT OF IMRF PENSION PLANS.*

*Any and all documents, emails, reports, memos, letter submissions, correspondence, meeting notes between Rock Island County Human Resources and/or Rock Island County designated IMRF agent, Rock Island County Sheriff's Office and /or Rock Island County Sheriff's Office designated IMRF agent regarding GERALD BUSTOS' participation in the IMRF pension plan*

*Any and all documents, emails, reports, memos, letter submissions, correspondence, meeting notes between GERALD BUSTOS and his agents to Rock Island County and Rock Island County's agents regarding non participation in IMRF pension plan as SHERIFF.*

*Any and all IMRF audit summaries and reports, any and all documents, emails, memos, letter submissions, correspondence, meeting notes related to GERALD BUSTOS' nonparticipation as SHERIFF of Rock Island County in the IMRF pension plan.*

*Any and all documents, emails, reports, memos, letter submissions, correspondence, meeting notes related to budget or cost savings related to GERALD BUSTOS' nonparticipation in the IMRF pension plan.*

*Any and all documents, emails, reports, memos, letter submissions, correspondence, meeting notes discussing or reporting that neither GERALD BUSTOS or Rock Island County would make contributions to IMRF while GERALD BUSTOS was SHERIFF.*

*A copy of every pay check awarded to GERALD BUSTOS from August 1, 2013 through July 31, 2017 including gross pay; itemized deductions by specific line items to include healthcare, pension, FICA tax, etc., and final net pay. In addition, paycheck identifies responsible county entity for payment.*

*A copy of every awarded stipend, bonus, uniform allowance, specialty payment of any kind that contributed to the total compensation package of GERALD BUSTOS from August 1, 2013 through July 31, 2017.*

*A copy of GERALD BUSTOS' W2 tax form as an employee of Rock Island County for the years 2013, 2014, 2015, 2016.*

*From August 1, 2013 through July 31, 2017 any and all records specific to Rock Island County's contributions to GERALD BUSTOS' IMRF pension plan as it relates to his total compensation package. Please itemize each contribution by each payroll.*
